## SMART WATER

#### **PROGRAMME**

In New Zealand, water is our most precious resource, yet it's often taken for granted and perceived to be unlimited.

Our Smart Water programme, a partnership between Hamilton City, Waipā District Council and Waitomo District Council, aims to foster a greater understanding and appreciation of our water from source to tap.

We also support schools, organisations and communities to value water and use it in an efficient way.

We coordinate several projects and campaigns across the sub-region that

- reduce the amount of water being used all year-round, particularly during the summer months,
- increase community understanding around the importance of saving water and that water is a precious resource, and
- increase awareness of different ways to save water and foster sustainable water habits.

#### WHAT DO WE DO?

Our Smart Water programme aims to change the way people think about, and the way they use water. By using behaviour change techniques, the community-based social marketing approach aims to encourage lasting changes in water consumption.

Our programme has four main components:

- Year Round a series of initiatives aimed at maintaining and emphasising water as a precious resource. A range of activities are offered from competitions, face-to-face engagement at local events, water-efficient giveaways, case studies and display banners.
- 2. Summer Demand Management a communications plan provides a structured approach including raising awareness via mass-marketing on radio, newspapers and digital. The community understands why we need to conserve water and how to make savings an everyday habit. If needed, water restrictions are put in place via Water Alert Levels.
- 3. Schools Education Smart Water Schools provides an online education programme for teachers and students. Resources are designed to fit within the NZ curriculum guidelines and are underpinned by key aims and dimensions of environmental education. We also offer In-school lessons with a specific focus on valuing and using water efficiently.
- Website a fun, interactive, educational platform. A popular go-to for water-saving tips, advice, videos and more.
